**INTRODUCTION:**

Jyothi hospital is a charitable Catholic Mission hospital which provides health care services to the sub-urban population residing in and around Kuruda, Balasore, Odisha. It is a minority Christian Institution owned and managed by the Roman Catholic Diocese of Balasore. Jyothi Hospital has been rendering comprehensive health care services since 1999. It is committed to look after the poor and the sick irrespective of caste, creed and colour after the model of Jesus Christ.

St. Thomas School of Nursing is built in the campus of Jyothi Hospital in the year 2008 to continue the healing mission of Jesus. St. Thomas School of Nursing owned and managed by the Roman Catholic Diocese of Balasore, which is a minority Institution recognized by the Indian Nursing Council & Odisha Nursing Council.

The General Nursing and Midwifery Course (G.N.M) is a 3 years training programme. All aspects of General Nursing and Midwifery are taught in this course. Most of the teaching and training is imparted in the school of nursing, in Jyothi Hospital and in other nearby hospitals, if needed, to gain more practical knowledge and experience. The students will be permitted to sit for the Board Examination according to the rules and procedure of the Mid India Board of Education (MIBE). On successful completion of 3years of study, the students are eligible to receive Diploma in General Nursing and Midwifery. This Diploma will be awarded by Mid India Board of Education of the Nurse's League of Christian Medical Association of India (C.M.A.I) and registered under Odisha Nursing Council. The Diploma Awarded is registrable by any State Council in India as this Board is recognized by the Indian Nursing Council.

St. Thomas College of Nursing, established in 2023, is a promising institution committed to nurturing competent and compassionate nursing professionals. With its recognized status from the Odisha Nursing Council and Indian Nursing Council, affiliation with Odisha University of Health Sciences (OUHS), the college aims to provide a high standard of education in the field of nursing. ## **GENERAL NURSING AND MIDWIFERY:**

- **ELIGIBILITY FOR APPLICATION**

### **GNM**

1. Candidate must have passed 10<sup>th</sup> and +2 with English and must have obtained minimum of 40% at the Qualifying examination and English individually from any recognized board.
2. Age: 17 years on the date of admission. (S.C & S.T. as per Govt. Regulations)
3. Minimum Weight – 40Kgs and a minimum height of 150cms.
4. Sex: irrespective of sex all can apply provided they are in good health, however male and married ones will not be given hostel facility.

### **BSc Nursing**

1. The candidates must be minimum 17 years of age as on 31.12.2026 i.e., the candidate should have been born on or before 31.12.2009.
2. The candidates must have passed 10+2 or equivalent examination with Science or vocational (Physics, Chemistry & Biology) from CHSE, Odisha or any other Board or Council or University equivalent thereof.
3. The candidates passed 10+2 examination in Science (Physics, Chemistry & Biology), conducted by National Institute of Open School are also eligible to apply.
4. The candidates must have passed in the subject of PCB & English individually and must have obtained a minimum of 45% marks taken together in PCB at the qualifying examination i.e. (10+2). In case of candidates belonging to SC/ST, the marks obtained in PCB taken together in qualifying examination shall be

40%. English is a compulsory subject in 10+2 for being eligible for admission to B.Sc.Nursing Course.

5. Only students who qualify in the entrance examination conducted by the OJEE will be allowed for admission to the Basic B.Sc. Nursing course. NEET qualified candidates will not be eligible for admission in Basic B.Sc. Nursing course in Odisha. [This supersedes any information given at clause 7.3.1 (last para) of the OJEE information brochure 2025].
6. Minimum qualifying marks for Common Entrance Test (OJEE)
7. Outside Odisha resident candidates can appear the entrance examination but can take admission in the management quota only.
8. Both female/male candidates are eligible to apply.

❖ **COMMON ENTRANCE TEST (CET) For GNM**

1. The candidates will have to bear all expenses in connection with the entrance test, interview and will have to make their own arrangement for food and accommodation during the days of interview and entrance test.
2. CET will be conducted by MIBE(Mid India Board of Examination).The questions will be of 100% multiple choice in English with Hindi translation.

**The test will consist of following sections:**

**Section I**                      General Knowledge

**SectionII**                      General Aptitude

**Section III -**                      Basic Maths (Adding, Subtraction, Multiplication, Division, Decimal operation, fractional operations, percentage and reading, comprehension. Reading comprehension will consist of reading a passage and answering the MCQ (Multiple Choice Question).

The test will be of 2hours and will be conducted at St. Thomas School of Nursing, Jyothi Hospital Campus, Kuruda, Balasore.

**THE DATE OF THE PNT IS 15<sup>TH</sup> JUNE 2026. ANY CHANGE IN THE DATE SHALL BE INTIMATED TO THE CANDIDATE.**

**Candidates should pay Rs 500/- towards the PNT fees at the examination venue.**

**COMMON ENTRANCE TEST(CET)FOR BSC NURSING.**

- **The Entrance Examination for Basic B.Sc Nursing course (OJEE) will be conducted at various centers.**
- **This examination will consist of one question paper of 100 Multiple Choice Questions, each carrying one mark.**
- **There will be no negative marks for wrong answers.**

- The syllabus for Common Entrance Test shall include the subjects of Physics, Chemistry, Biology and English of +2 examination course.
- Minimum qualifying marks for entrance test shall be 50% marks.

Candidates are advised to check regularly the OJEE website ([www.ojee.nic.in](http://www.ojee.nic.in) / [www.odishajee.com](http://www.odishajee.com)) for updates and further informations.

❖ **SELECTION (GNM)**

1. The school management may conduct personal interview of candidates and select them on the basis of PNT marks, +2 marks and personal interview marks.
2. Step-I: MIBE conducts a Pre-Nursing Test(PNT)
3. Step-II: An initial list of about 50 candidates – based on the PNT merit result – will be called for.
4. All original documents need to be produced at this stage.
5. Step III: the institute will conduct a suitability assessment, which includes language and aptitude test, followed by interviews. Marks will be awarded for each of the assessments.
6. In order of rank, the first thirty candidates will form the provisional selection list. This list will be presented alphabetically.
7. The wait-list candidates will be listed in order of rank.

8. The decision of the selection board of the nursing school will be final. For genuine reasons the Management will have the right to deny admission of any candidate even-if

10. other wise eligible.
11. The selected list will be displayed in the school notice board and the selected candidates will also be intimated individually.
12. The Selected Candidates shall deposit the 1<sup>st</sup> year fees along with the original certificates to secure the admission. (On or before the intimated time.)

❖ **MEDICAL CHECK UP**

1. Candidates listed in the Provisional Selection List are required to undergo a complete medical examination at Jyothi hospital including Laboratory investigations, Chest X-ray, ECG and those expenses are met by the students.
2. The admission is liable to be cancelled if a candidate is found medically unfit to undergo the nursing training.

❖ **ADMISSION (GNM)**

1. All selected candidates are required to get admitted on September 1<sup>st</sup> 2026.
2. At the time of admission, all the original certificates are to be submitted for verification and retention at the school along with the full annual fees.
3. The parents or legal guardians must accompany the candidate on the day of admission and sign-up the formal agreement and the admission register.
4. The candidates who want to have hostel facility should apply for it.

❖ **DOCUMENTS REQUIRED FOR SELECTION**

1. Application form duly and neatly filled by the candidate.
2. 3 set Photo-copy of the original Certificates of Std. X and XII.
3. A copy of the Marks sheet and a conduct certificate from the institution last attended.
4. Recommendation letter from the Parish Priest/ Pastor of the respective church (if he/she is a Christian) or two other responsible persons (if non-Christians), declaring the conduct and the free status of the candidate.
5. Transfer Certificate and Conduct Certificate

6. Migration Certificate (if one is from outside of the state of Odisha)
7. 3 Copy of Aadhar- Card
8. Latest Passport size photograph.(5)
9. Copy of the Caste certificate for SC/ST candidates.
10. Copy of income certificate.

❖ **PRELIMINARY PERIOD: (GNM)**

There is a preliminary period of 12 weeks. An examination to assess the student's ability to continue the course shall be held at the end of 12<sup>th</sup> week. Successful candidates will only be allowed to continue the course. A careful and continuous assessment of a student's knowledge, abilities and attitudes will determine whether they should continue in nursing course after the first three months of successful completion of formal school test.

❖ **VACATION AND HOLIDAYS: GNM**

Annual leave 1<sup>st</sup> year & 2<sup>nd</sup> year: 28 days

Annual leaves in 3<sup>rd</sup> year : 14 days

Study leave : 7 days per annum

In case of illness students may avail 10 days of sick leave per year.

❖ **VACATION FOR BSc Nursing**

❖ **WITHDRAWAL AND DISMISSAL:**

If any student decides to withdraw voluntarily from school, after the preliminary period or anytime before completing the course, they shall pay back to the school all the money spent on them by the school. The school reserves the sole right to dismiss anyone whose work of conduct is not found satisfactory during the period of training.

If a student manages to take admission on fake certificates, her admission will be cancelled automatically and fees will not be refunded.

❖ **UNIFORM:**

The students should provide themselves with the prescribed uniform of the institution. Besides being clean, it should be worn with decorum.

❖ **DISCIPLINE:**

Strict discipline should be maintained in the school, hostel and hospital. Hostlers are expected to comply with the rules and regulations of the institution. They are liable to be dismissed for grave misconduct, insubordination, gross negligence in duties and disloyalty to the institution.

**If a student is found to be unfit for the nursing profession or progress is unsatisfactory, they shall not be allowed to continue the training.**

❖ **CURRICULUM:**

The curriculum of the Nursing College /school shall include the clinical experience, minimum subject content and time allotment required by the Indian Nursing Council as prescribed in the syllabus.

❖ **CLINICAL EXPERIENCE**

1. Students may be assigned for observing and practicing what they are learning, under careful supervision in the clinical area.
2. They are sent to the nearby villages for community experience.
3. Students are sent to Parent hospital, Jyothi Hospital and DHH Balasore for the Clinical experience.

❖ **NOTE:**

1. All the said syllabus and regulations are prescribed by the Indian Nursing Council, NewDelhi, approved by the Govt. of Odisha
2. Efficient theoretical training is being given by the qualified faculty in the institution.
3. The Annual examination (General Nursing & Midwifery) will be conducted by the M.I.B.E. Board, Nagpur.
4. Diploma will be issued by the M.I.B.E. Board Nagpur & Registration of the Diplomas will be with Odisha Nurses & Midwifery Registration Council, Odisha.

❖ **ELIGIBILITY FOR ADMISSION TO EXAMINATION**

A candidate shall be eligible for the admission to the board examination if the Principal of the school certified that:

1. She/He has completed not less than eleven month of the course.
2. A candidate must have minimum of 80% attendance (irrespective of the kind of absence) in theory and practical in each subject for appearing for examination.
3. The diploma shall not be awarded to the student till she has completed the clinical /field requirements.
4. The overall performance of the student and his/her conduct during the entire academic year has been satisfactory.
5. The student has passed in the internal assessment on each subject i.e. both in the teaching and practical (5) by securing 50 % marks separately in theory and practical.
6. The record of practical experience should be completed.

❖ **SUPPLEMENTARY EXAMINATION:**

The Board shall conduct supplementary / late-examination within six months of the annual examination:

A.If a student fails in two or more theory paper / Practical. She will not be allowed to proceed to the next year. She will sit for a supplementary examination after six months.

## ❖ COMMENCEMENT OF THE PROGRAMME

The GNM training programme will start on 1<sup>st</sup> September for the session 2026-2027 which may be subjected to change.

## ❖ LIVING AND RECREATION:

The school can provide hostel facility for needed students. Outdoor and Indoor recreation facilities are available. Variety of recreational, cultural and social events is organized. Facilities for other activities such as gardening are also arranged for the students.

## ❖ COURSE:

1. Course begins on August 18<sup>th</sup>. At the time of the 1<sup>st</sup> three months of the training student should pass the PTS Exam.
2. Student whose fees are upto date & who make the minimum grade in the internal exam (at 6 months & 9 months) will be eligible to appear for annual examination.

**In the following instances the students are not permitted to write the Board exam.**

1. Do not make minimum grade for practical and theory internal examination.
2. Who underwent serious disciplinary action.
3. Who are found medically, physically, psychologically unfit.

## ❖ IMPORTANT POINTS TO BE NOTED

1. Medium of instruction is English.
2. **Internal Assessment** 25% of the total marks obtained by the students for the overall performance in the academic and clinical areas throughout the year. The **final examination** carries 75% marks.
3. **Preliminary period:** All selected candidates shall be on a three months' probation period, which shall be included in the course of the training. At the end of this period, they have to appear for an examination and only those who are declared successful in this examination will be promoted to the regular General Nursing and Midwifery course.
4. **Examination:** Each year the students have to appear for the Board Examination and Pass the Examination. The Students are required to obtain average 60 % marks in the theory and practical examination to be qualified to appear for the Annual Examination of Board
5. **Completion of Training:** Each Academic year will be completed only when the student

satisfactorily completes that year's classroom and clinical work and remains a student of the respective year until she has completed all the requirements.

6. The school/College /hospital authorities have the right to discipline or dismiss a student for inefficiency, misconduct or behavior which is detrimental to the Institution or the Hospital atmosphere.
7. The students those who stay in the hostel during the training period have to abide by the rules and regulations of the school and the Hospital.
8. Students are allowed to meet only those visitors whose names are on the list of guardians on Saturdays between 1 p.m.to 5 p.m. and Sundays.
9. Students are not given any leave during the period when regular classes are in session. If the number of leave availed are more than 28 days of annual leave and (10 days of sick leave, in case of sickness), it shall be made up by the students at the end of the current academic year from the annual leave. Off days of the week cannot be used for this purpose. A student having more than 28 days excess sick or emergency leave is detained from the Annual Board Examination and she may be allowed to appear for the late examination which is usually held about 6months after the annual examination. This privilege is granted only once during the entire training period.
10. The date of admission and examination are subject to change.
11. This prospectus also is subject to change from time to time
12. Every year the students should undergo a medical examination. If a student is found medically unfit, she will have to discontinue the course. Any student suffering from illness requiring long rest will be sent home for recuperation and she will have to join the junior group on returning.

❖ **FEES STRUCTURE**

Fees as mentioned above for the first year are to be paid at the time of admission and thereafter, the yearly fees are to be paid at the beginning of the each session of each year. In case of any student decides to discontinue her study in between the course for any reason whatsoever, except for serious Medical reason she is bound to pay the full fees for the remaining entire course (3 Year) Fees once paid will not be refunded.

# **BACHELOR OF SCIENCE INNURSING (B.Sc.N)**

## **ELIGIBILITY**

The candidate must:-

1. Be of minimum 17 years of age as on 31.12.2026.
2. Have passed 10+2 in Science (Physics, Chemistry & Biology) from CHSE, Odisha or any other board or Council or University equivalent thereof.
3. Have passed in the subjects of PCB & English individually and must have obtained a minimum of 45% marks taken together in PCB at the qualifying examination i.e.(10+2).Candidates belonging to SC/ST the marks obtained in PCB taken together in qualifying examination be 40% instead of 45 % as stated above.
4. English is a compulsory subject in 10+2 for being eligible for admission to B.Sc Nursing.
5. Be medically fit to undergo the course.
6. Only students who qualify in the entrance examination conducted by the OJEE will be allowed for admission to the Basic B.Sc. Nursing course. NEET qualified candidates will not be eligible for admission in Basic B.Sc. Nursing course in Odisha. [This supersedes any information given at clause 7.3.1 (last para) of the OJEE information brochure 2025].
7. Outside Odisha resident candidates can appear the entrance examination but can take admission in the management quota only.

## **SELECTION PROCESS**

1. All candidates seeking to join the College of Nursing, should apply to the Government of Odisha counseling process.
2. Candidates who also seek to be considered for the Management Quota and fulfill the eligibility criteria listed above, should additionally also apply to St. Thomas College of Nursing for the same in the prescribed form available with the website and submit all required documents as listed.

### **Govt. Quota:**

1. Admission for Government quota will be based on State counseling.
2. Lapsed seats, if any from the Gov. quota will be filled by the Management.

### **Management Quota:**

1. Selection committee of the College of Nursing will undertake selection of the students of Management Quota through a Suitability Assessment which includes written assessment exam, aptitude test and interviews.
2. Outside Odisha resident candidates can appear the entrance examination (OJEE) but can take admission in the management quota only.
3. Only students who qualify in the entrance examination conducted by the OJEE will be allowed for admission to the Basic B.Sc. Nursing course. NEET qualified candidates will not be eligible for admission in Basic B.Sc. Nursing course in Odisha. ### **RULES AND REGULATIONS**

## **SCHOOL/COLLEGE:**

1. Students are to be regular and punctual at classes, practical and academic exercises.
2. In case of non-attendance of classes a student is to submit a written request giving reasons to the principal.
3. All students should present themselves neat and tidy in the dress and wear the prescribed uniform during clinical hours.
4. The certificates are issued to successful candidates only after they have completed the full course
5. During the period of training students do not marry.
6. Ragging is strictly prohibited
7. The student will not be sent home alone unless a permission letter is produced from parent or guardian stating “that student can travel alone”
8. In case of medical emergency the treatment including surgery and anesthesia will be undertaken at the discretion of the medical officer with the consent of the principal and student.
9. The Governing Board reserves the right to make necessary changes in the policies as the need arises.
10. Use of mobile phone: The use of mobile phone by the student will be decided during the admission in consultation with the guardians.
11. Violation of the rules & regulation of the school, hostel or hospital by a student shall be subjected to any disciplinary action, even the dismissal of the candidate.
12. On admission the guardian / Parent has to give in writing the names of the visitors who would be permitted to visit the candidate including the name & address and the photograph of the visitors.

## **HOSTEL**

- All students reside in the hostel attached to the school under the direct care and supervision of the sister-in-charge of the hostel.
- Students are allowed to go out ONCE in a month for shopping with their guardians.
- Students are to be back in the hostel before 5.00 PM.
- No guardian or parents or relatives or friends are expected to meet the students without the permission of the Principal/Concerned person. Management has the right to refuse permission to the visit or stay at any time.
- Students will not be allowed to go outside without prior permission.
- In case of illness, inform the warden and she in turn will promptly report to the principal.
- Relatives and friends are not permitted to visit the students during clinical hours.
- Students are permitted to be in the Hospital only during clinical posting. Any extra visit to the hospital on/off duty requires permission from the warden.

- Students are not allowed to keep jewellery and other valuables with them in the hostel.
- The institution does not take responsibility for loss of valuables or money.
- Students are not allowed to wear rings, bangles and big chains or necklace and nail polish while on duty.
- Relatives are not allowed to enter in the hostel dormitory.
- Breaking of furniture, equipment of the school, hospital, hostel should be reported and replaced by the one responsible for the loss.
- Ragging is strictly forbidden and punishable.

### **ANTIRAGGING POLICY & COMMITTEE**

**“Ragging is any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness to any student, indulging in rowdy or undisciplined activities which cause or likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the psyche of a fresher or a junior student”.** (Honorable Supreme Court of India)

Indian Nursing Council (INC) has made it very clear that all INC approved institutions should strictly follow the directions of Hon’ble Supreme Court of India and Raghavan Committee recommendations without any exception. It is clearly mentioned in the regulation that RAGGING is totally banned and anyone found guilty of ragging and /or abetting ragging is liable to be punished INSTRUCTIONS TO STUDENTS

\* **RAGGING IS BANNED**, thereof all the students of St. Thomas School/College of Nursing are advised to refrain from all such activities which are directly or indirectly related to ragging.

\* All students will be bound to obey the appropriate punishments, if found guilty, without any prior indications whatsoever.

\* All students should intimate the incidents of ragging, if any, to the officials of Anti Ragging Committee Members (the names and phone numbers of members in the respective committee is displayed on the notice board of the college/School of nursing.), immediately after witnessing the matter.
